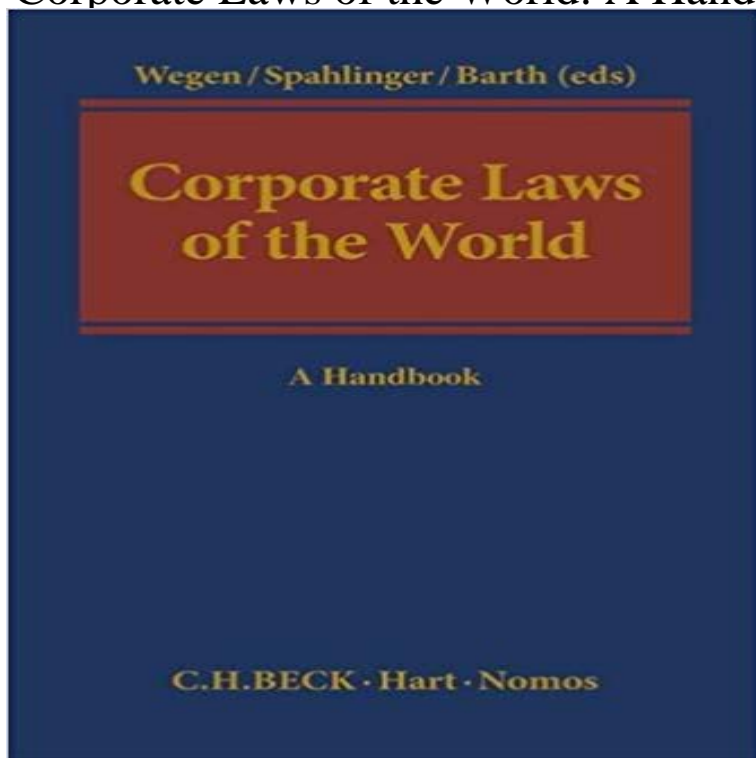


## Corporate Laws of the World: A Handbook
